



Conditions of participation for Ballistol GmbH's competition

Last updated: January 2021

1 Operator or organiser

The organiser of the competition is Ballistol GmbH, based at Ballistolweg 1, 84168 Aham, Germany.

2 Participation

Participation in this competition is free and shall be based exclusively on these conditions of participation in conjunction with the privacy policy.

3 Competition period

Participants can take part in the competition from 1 June 2020 until 30 September 2021. Entries received after the closing date shall not be considered for the draw. The competition may be ended when the prize money has reached €5,000.

4 Eligibility

4.1 Eligible participants

Natural persons who have reached the age of 18 and legal entities are eligible to take part in the competition. Participation in the competition is not limited to the organiser's customers. Should a participant have restricted legal capacity, the consent of their legal representative is required.

All those involved in conceptually designing and implementing the competition, the operator's employees and said employees' family members are not eligible to take part in the competition. Furthermore, the operator reserves the right to exclude people from taking part in the competition at its own discretion if there are justified reasons for doing so, for example:

- a) in the event of manipulation in connection with access to or implementation of the competition;
- b) in the event of these conditions of participation being violated;
- c) in the event of unfair trading; or
- d) in the event of false or misleading information being provided in connection with participation in the competition.

The operator reserves the right to exclude fraudsters' email addresses or attempts at fraud in general from the competition. In these cases, winnings may also be subsequently withdrawn and reclaimed.

4.2 Participating products

Only purchase receipts that prove a participant has purchased Ballistol VarioFlex may be submitted. If the product is not clearly visible from the purchase receipt, a photo of the purchase receipt next to a can of Ballistol VarioFlex must be submitted. Please note that the receipt must be fully legible. Each purchase receipt may only be submitted once, regardless of how many cans of Ballistol VarioFlex were purchased.



4.3 Repeat participation

Each participant can increase their chances of winning by submitting several purchase receipts.

5 Running the competition

To be able to take part in the competition, participants must submit their purchase receipt as proof that they have purchased Ballistol VarioFlex. The participant must photograph or scan the purchase receipt and send it to gewinnspiel@ballistol.de along with their details (first name, surname and email address). The participant is obligated to provide this data both truthfully and in full. Each participant shall receive confirmation of receipt by email as proof that their email has been received.

6 Winning, notification and transferring the prize

The operator is raffling at least €1,000 in cash. For each receipt submitted, the prize money shall increase by €0.50, up to a maximum prize of €5,000.

The winners shall be determined after the closing date in a random draw that all participants are entered into.

The winner of the draw shall be informed that they have won the prize by means of a separate email sent within three weeks of the competition ending, but by no later than 15 October 2021. If the winner does not respond within a period of three weeks after being prompted to do so twice, the prize shall be transferred to another participant.

The prize shall be handed over to the winner exclusively by Ballistol GmbH. This requires the winner to provide their account details. The winner is responsible for paying any tax due on the prize. If payment is made in a foreign currency (not in euros), the conversion shall be based on the European Central Bank's daily euro reference exchange rate. The organiser shall be released from all obligations on handover of the prize. Liability claims against the organiser arising from use of the prize are generally excluded.

7 Premature termination of the competition

The organiser reserves the right to cancel or terminate the competition at any time without any need to give prior notice or to state reasons for doing so. The organiser shall make use of this option particularly if proper implementation of the competition cannot be guaranteed for technical reasons (e.g. viruses in the computer system, tampering or faults in the hardware and/or software) or for legal reasons. If termination such as this was caused by a participant's behaviour, BALLISTOL GmbH may demand compensation from this individual for the damage incurred.



8 Data protection

Participants need to provide personal data to take part in the competition. The participant warrants that the personal details they provide (such as their first name, surname and email address) are true and accurate. The data provided shall be stored electronically for the purposes of processing and handling the competition. The organiser shall delete the data once the competition is complete.

The organiser would like to point out that all of the participant's personal data shall neither be passed on to third parties nor given to them for use without the participant's consent.

If they win the competition, the winning participant agrees to a photo being published in connection with their name and place of residence in the advertising media that the organiser uses. This includes the operator announcing the winner on its website and its social media platforms.

The participant may revoke the consent they have provided at any time. Any revocation shall be sent in writing to Ballistol GmbH, Ballistolweg 1, 84168 Aham, Germany, or to info@ballistol.de, with the participant stating their first name, surname and email address. Once a participant has revoked their consent, their collected and stored personal data shall be deleted immediately.

11 Applicable law

A legally permissible provision that most closely reflects the economic meaning and purpose expressed in the invalid provision shall apply in place of the invalid provision. The same shall apply in the event that these conditions of participation contain a loophole.
